Srinagar, the 16th October, 2017

SRO 440 .-In exercise of the powers conferred by subsection (2) of section 9 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938, the Government of Jammu and Kashmir authorizes the carrying out of the Field Firing and Artillery Practice throughout the area notified vide SRO notification 439 dated 16-10-2017 for a period of 10 years with effect from 03.06.2014 subject to the strict compliance with the provisions of the Manoeuvres, Field Firing and Artillery Practice Act, 1938 and the Jammu and Kashmir Manoeuvres, Field Firing and Artillery Practice Rules, 1973, as amended vide SRO-183 dated 19-04-2017. The authorization to carry out the Field Firing Range and Artillery Practice in the notified area shall, further be subject to compliance with the following conditions:-

(i) The Army shall take all possible measures to prevent loss of life, live stock, public/private property and damage to standing crops.

(ii) The Range shall not be used for field firing practice during school examination, harvest/sowing season and on public /gazetted holidays.

(iii) The Army shall make adequate arrangements in regard to medical facilities including doctors and ambulances during the days notified for firing.
